DISCUSSION OF AGENDA ITEM 1 BY ERIC MAGEE WITH ALLISON, BASS, MAGEE. THE 2020 CENSUS FOUND THE TOTAL POPULATION OF POLK COUNTY (NOT INCLUDING THE PRISON POPULATION) TO BE 46,409, MAKING THE IDEAL POPULATION OF EACH PRECINCT 11,602 PEOPLE. BASED ON THIS DATA, PRECINCT 1 WAS OVER THE IDEAL POPULATION BY 2,119, PRECINCT 2 WAS UNDER BY 162, PRECINCT 3 WAS UNDER BY 1,438, AND PRECINCT 4 WAS UNDER BY 518.

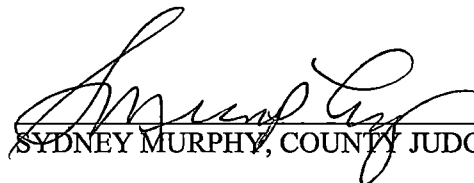
MR. MAGEE ASSISTED THE COURT IN DEVELOPING A PROPOSAL TO SHIFT THE POPULATION FROM PRECINCT 1 TO THE OTHER PRECINCTS WHILE MAINTAINING THE BALANCE OF ROADS CURRENTLY MAINTAINED BY THE COMMISSIONERS AS MUCH AS POSSIBLE AND ALSO KEEPING EACH ELECTED PRECINCT OFFICIALS HOME AND OFFICE ADDRESS WITHIN THEIR CURRENT PRECINCT BOUNDARIES (EXCEPT IN THE ONE CASE OF A JUSTICE OF THE PEACE NOT SEEKING RE-ELECTION IN 2022). THE PROPOSAL THAT WAS DEVELOPED WAS POSTED TO THE WEBSITE ON TUESDAY, NOVEMBER 9, 2021.
